Additional Violation Information

The Cottonwood Water and Sanitation District (“Cottonwood”) was required to collect samples for Synthetic Organics for its five deep groundwater wells twice in the same monitoring year in two different quarters, between 01/01/2017 and 12/31/2019. The violation was issued due to the fact that for one of the five wells, one of the samples for Synthetic Organics was collected with a group of samples intended for a separate application with the EPA that were submitted to the lab as “not for compliance purposes”. The result of this error was that the compliance sample and results for Synthetic Organics did not get reported to the CDPHE a) on time and b) under the compliance protocol established for Cottonwood. The two sample groups for Synthetic Organics for Well D3 were collected on February 12, 2019 and October 16, 2019.

- a. First sample group was collected in the first quarter of 2019 – Lab results for Synthetic Organics: Non-Detectable for all constituents.
- b. Second sample group was collected in the fourth quarter of 2019 – Lab results for Synthetic Organics: Non-Detectable for all constituents.
